The club will hold an Open to Centre trial for solo machines only. To be held under the National Sporting Code rules of the ACU, the Standing Regulations for trials, these supplementary regulations and any final instructions which may be issued up until the start of the trial.

Entry fees: £14.00. Cheques payable to Redditch MCC. Must include 2 x SAE. Entries will close on the 2nd December 2008. Entries will be accepted up until 8:30am on the day of the trial at a cost of £17.00, but riders will not be eligible for awards or championship points.

Venue and Start Time: S. E. Davies & Sons, Edgioke Lane, Astwood Bank, Redditch. 1st rider away at 9:30am, the rest at one minute intervals. The method of marking for this trial will be TSR22A.

Course: The course will be of 20 miles. The trial will be of a sporting nature and will have 2 routes. Experts and intermediates will ride the hard route, club men and over 40 the easier route.

Note: Events run as a grade A open to Centre Trials. Any affiliated member of a Midland Centre ACU club can enter the trial. Awards will be given to the winner of each class providing there are 10 entries in that class. Any one riding out of class will not be eligible for an award or championship points.
